

Note: The Company was originally incorporated as Solarium Green Energy LLP as a limited liability partnership under the provisions of the Limited Liability Partnership Act, 2008 vide Certificate of Incorporation dated December 17, 2015, issued by the Registrar of Companies, Gujarat, Ahmedabad. Later on, it was converted to a private limited company under Part I chapter XXI of the Companies Act, 2013 and consequently, the name of the company was changed to Solarium Green Energy Private Limited with a fresh certificate of incorporation dated February 24, 2022 issued to the company by the Registrar of Companies, Ahmedabad. Therefore, the Company been incorporated on February 24, 2022, the First financial year of the Company closed as on March 31, 2023. As the company was incorporated by conversion of LLP, the previous years financial year figures of LLP firm are shown in the financial statement of the company, Balances of Partners Current Capital Account stood in the balance sheet of LLP as at 31.03.2022 are shown as unsecured loans in the current financial statements. Pursuant to conversion, in the absence of GST and other business registration to continue the business transactions, the assessee continued the transactions in the books of LLP upto 31.03.2022 and the closing balances as at 31.03.2022 were transferred in the books of the company which are shown as comparatives in the financial statement as of 31 March, 2023.
