B. A listed entity which has listed its specified securities on the SME Exchange.

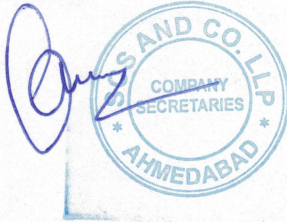
